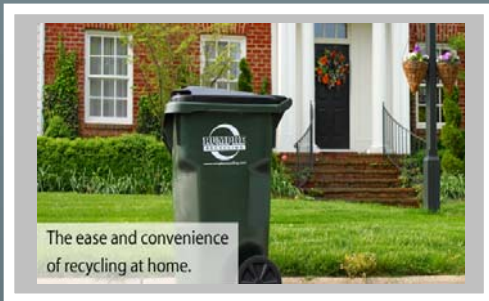


RUMPKE CART PLACEMENT:

1. FACE THE CART TOWARD THE STREET (WHEELS AWAY FROM STREET).
2. POSITION THE CART WITHIN TWO FEET OF THE CURB.
3. KEEP A FOUR FOOT DISTANCE BETWEEN THE CART AND ANOTHER OBJECT.



RUMPKE WILL CONTINUE TO PROVIDE TRASH AND YARD WASTE PICKUP ON MONDAYS AND RECYCLING EVERY OTHER MONDAY.

IN GENERAL, THE FOLLOWING TYPES OF MATERIALS ARE RECYCLABLE:

PAPER: NEWSPAPER, MAGAZINES, CARDBOARD, COMPUTER PAPER, JUNK MAIL, ENVELOPES, CATALOGS, CEREAL AND DRY FOOD BOXES, TELEPHONE BOOKS.

PLASTIC BOTTLES/JUGS FROM SODA, MILK, SPORT DRINKS, WATER, LAUNDRY DETERGENT, CONTACT SOLUTION, SHAMPOO/CONDITIONER, JUICE (LIDS ARE OK IF LEFT ON EMPTY BOTTLE).

CANS (ALUMINUM & STEEL) FROM BEVERAGES, FOOD, SOUP. PLEASE MAKE SURE ALL CANS ARE EMPTY.

GLASS BOTTLES & JARS FROM FOOD AND BEVERAGES.

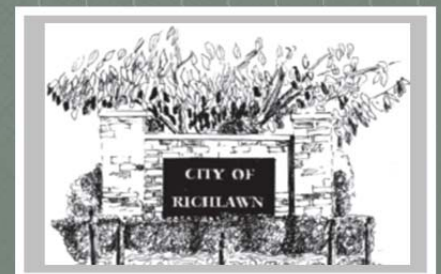

Richlawn Ordinances Parking Regulations

- 1) No parking on Hubbards Lane.
- 2) No parking on the street which obstructs more than one lane of traffic.
- 3) No parking within 25 feet of an intersection.
- 4) No parking on Heady between Shelbyville Road and the intersection of Gibson and Don Allen Roads.
- 5) No parking on the street for a period of time longer than 15 minutes between 2:00 a.m. and 6:00 a.m.
- 6) No parking in a front yard except:
 - a) For a period shorter than 15 minutes;
 - b) When the driveway is filled;
 - c) When a driveway is being resurfaced; or
 - d) During an emergency
