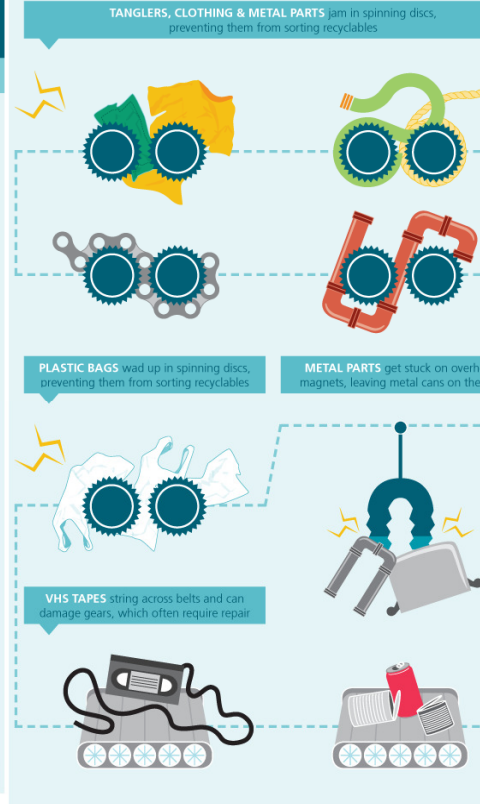


How Recycling DOESN'T Work

WHY? Rumpke collects recyclables and sorts them at a Material Recovery Facility (MRF). Some items damage or hinder sorting machines, preventing proper sorting of recyclables.
